- First 7 days:                                      \$4.00 per ft. per day                                      Plus electricity - \$25 per day
- 7 – 14 days:                                      12.5% discount or 3.50 per ft. per day                                      Plus electricity - \$25 per day
- 14 – 21 days:                                      15% discount or \$3.20 per ft. per day                                      Plus electricity - \$25 per day
- Over 21days:                                      25% discount or \$ 3.00 per ft. per day                                      Plus electricity - \$25 per day

**Off Season Rate: October – April: \$ 2.00 per ft. per day, plus electricity – \$25 per day.**

**Terms & Conditions:**

- (1) The RHADC will not be responsible for any theft from or damage of any sort to the Vessel berthed at the RHADC marina, including but not limited to any electrical malfunction or damage that may occur due to low voltage.
- (2) The Vessel shall be berthed at the RHADC Marina where the Dockmaster or the Officer(s) of the RHADC shall direct.
- (3) In the event of a hurricane, emergency or any other cause, the RHADC reserve the right to require that you move your vessel from the RHADC marina immediately. It is agreed that the Owner/Skipper will move the Vessel upon being notified by the Dockmaster or Officer(s) of the RHADC. That in the event of an emergency, which shall be solely determined by the Dockmaster or Officer(s) of the RHADC, and in the absence of the Owner or Skipper from the Vessel then the Dockmaster or Officer(s) of the RHADC may move the Vessel from the Marina. The Owner/Skipper shall hold the RHADC, Dockmaster and Officer(s) harmless from all and any damage caused to or by the Vessel.
- (4) **Sewage Management: RHADC provides sewage disposal for Transit & Visiting Yachts - \$25 per pump out.** Sewage disposal is prohibited in the RHADC Marina and there is no sewage discharge 500 metres from the Bermuda Coastline. The renter shall not discharge any sewage or otherwise empty any latrines into the Marina waters, or otherwise dispose of any garbage, oil, fuel or other material whatsoever in the Marina.
- (5) An Account will be opened under the vessel's name with our Accounts Office and the Owner/ Skipper accept responsibility for prompt payment of the account prior to departure from the marina.

- (6) No personal checks will be accepted.
- (7) The Owner/ Skipper hereby authorizes the RHADC to pay the account by charging the credit card listed above.

PLEASE ENSURE THAT YOUR CREW ARE AWARE THAT ONLY YOU HAVE CHARGE PRIVILEGES. YOU ACCEPT RESPONSIBILITY FOR CHARGES MADE TO YOUR ACCOUNT BY MEMBERS OF YOUR CREW OR FAMILY.

**Dock keys must be issued to the vessel owner/skipper at the time of arrival. The same must be returned to the Dockmaster or the Club Office prior to departure.**
